#### **About the Scheme**

The "Prime Minister's Internship Scheme" (PMIS) is a landmark initiative launched by the Ministry of Corporate Affairs, Government of India, aimed at empowering one crore Indian youth through industry-based internship opportunities over the next five years. The All India Rail Safety Council (AIRSC) proudly organizes and facilitates this scheme across the country, ensuring active participation of youth in top 500 reputed Indian companies.

This prestigious national internship programme offers a **12-month hands-on learning experience** in real-time business environments, providing exposure to diverse sectors and practical employment opportunities. The scheme serves as a bridge between **academic education and professional employability**, enhancing youth skills, knowledge, and readiness for the modern industry landscape.

## **Objective & Scope**

The PMIS, under AIRSC's coordination, is **independent** of all other skill development, apprenticeship, or student training programmes at both Central and State levels. It provides **industry-integrated learning**, enabling participants to gain genuine workplace experience.

AIRSC's involvement ensures structured monitoring, awareness campaigns, institutional linkages, and smooth implementation nationwide — especially supporting candidates from **Rail Safety, Industrial Safety, and Technical Streams**.

# **Internship Duration**

- Total Duration: 12 Months
- Practical Training: At least 6 months in actual workplace/industry setting
- **Academic/Online Learning:** Up to 6 months (skill & employability modules)

#### **Benefits for Interns**

- ₹4,500/- monthly assistance from the Government of India
- ₹500/- monthly contribution from participating industries
- ₹6,000/- one-time grant for incidental expenses (through Direct Benefit Transfer)
- Insurance Coverage under:
  - Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY)
  - o Pradhan Mantri Suraksha Bima Yojana (PMSBY)
- Certificate of Completion jointly issued by the All India Rail Safety Council (AIRSC)

## **Eligibility Criteria**

Applicants must fulfill the following conditions:

- Be an Indian national aged 21-24 years (as of last date of application).
- Not engaged in **full-time education or employment**.
- Candidates pursuing online or distance learning courses may apply.
- Must have completed High School / Higher Secondary / ITI / Polytechnic Diploma / Graduate degree (BA, B.Sc, B.Com, BCA, BBA, B.Pharma, etc.).
- Family income should not exceed ₹8,00,000/- per annum.

#### **Exclusions**

The following are **ineligible** to apply:

- Graduates from IITs, IIMs, NLU, IISER, NID, IIIT, etc.
- Holders of professional or postgraduate degrees such as CA, CMA, CS, MBA, MBBS, BDS, M.Sc, M.Com, etc.
- Candidates currently enrolled in **any government skill, apprenticeship, or internship** scheme.
- Candidates whose **family income exceeds ₹8 lakhs**, or any member is a **permanent Government employee** (Central/State/PSU).

# **Documents Required**

- Aadhaar Card (linked to mobile number)
- Proof of Age
- Educational Qualification Certificates
- Bank Account Details (for DBT)
- Income Proof / Self-declaration
- Any other supporting documents as notified

# Implementation & Coordination

The **All India Rail Safety Council (AIRSC)** shall act as the **National Coordinating Organization**, responsible for outreach, awareness, selection facilitation, and performance monitoring of the interns placed under this scheme in cooperation with industry partners and government institutions.

AIRSC shall ensure inclusion of candidates from **technical**, **rail safety**, **industrial safety**, **and allied vocational backgrounds** for broader national development under the *Skill India* and *Atmanirbhar Bharat* initiatives.

## **Important Notes**

- Monthly assistance and grant will be credited via **Direct Benefit Transfer (DBT)**.
- Internship period: 12 months continuous duration.
- Certificates will be issued **only upon successful completion** and evaluation.
